- 3. Administrative support in governance matters, on request and as communicated by PSQ.
- 4. Templates for Risk Management and Member Protection policies.
- 5. Supply Certificates of Currency and the Insurance Manual to confirm insurance cover for the club and its affiliates for: Public Liability, Product Liability, Group Accident for Voluntary Workers and Association Liability (including Director and Office Bearers and Entity Liability).
- 6. Letters of Support for funding applications, on request.
- 7. Support for the Club Delegate to attend the Annual General Meeting and Conference: subject to funding availability.
- 8. Sanctioning of events.
- 9. Equipment Control Kit and Rika Scoring machine for sanctioned events.
- 10. Material, activities and support for promotion of the sport.

### **Provided to PSQ Pistol Shooter Member:**

- 1. Affiliation to Pistol Shooting Queensland Ltd and Pistol Australia and their affiliated bodies
- 2. Membership cards.
- 3. Public Liability, Product Liability, Group Accident for Voluntary Workers and Association Liability (including Director and Office Bearers and Entity Liability).
- 4. Eligibility to access all the Pistol Australia registered events, as per the Pistol Australia Certificate of Rights.
- 5. Access to a genuine pathway to Olympic Games, Commonwealth Games and World Championship events.
- 6. Coaching, at all levels, in all disciplines.
- 7. Eligibility to join the State Squad in all disciplines.
- 8. Junior Development.
- 9. Training and accreditation for Pistol Australia Holster Proficiency accreditation.
- 10. Training and accreditation for Pistol Australia Range Official courses.
- 11. Training and accreditation through the Pistol Shooting Queensland Club Range Conduct Program.
- 12. Access to official rule books and Range Officer Guides for all Pistol Australia events.
- 13. Provision of the SCATT machine for recognised training.
- 14. Facilitation of Weapons Safety Course Training.
- 15. Organisation Declaration for Blue Card registration, on request.

# The \_\_\_\_\_ Pistol Club Inc agrees to:

- 1. Affiliate all its Category H members with Pistol Shooting Queensland Ltd in the 2013-14 year, as per Section 9 (1) of the Pistol Shooting Queensland Ltd Constitution:
  - '9 (1) **MEMBER CLUB:** An incorporated or non-incorporated body whose objectives state the club obligations to Pistol Shooting Queensland and to being a member of PSQ shall be eligible for admission as a Member Club if 100% of the applicant's Category H licensed members are members of the Company, and on approval of its application, and on payment of the subscription, or such other sum as may be determined from time to time by the Board.

### A Member Club shall be:

- (a) subject to the provisions of these Rules and the signed Membership Agreement
- (b) provided the use of Member services at the cost specified from time to time by the Board
- (c) eligible to participate in events and courses arranged by the Company
- (d) on payment of their fees, entitled to 1 (one) vote if the member is a compliant legal identity as described in rule 1 (22).'
- 2. Provide Pistol Shooting Queensland Ltd with a copy of the Club's current constitution.
- 3. Promote and support the sport of Pistol Shooting and all associations connected to Pistol Shooting Queensland Ltd: Refer PSQ Constitution '33 (9) The duty of Member Clubs to the Company shall be to:
  - (a) notify the Secretary of the Company of any change in the particulars given on the application form within 14 (fourteen) days of the change occurring
  - (b) sign and operate within the confines of the PSQ Club Membership Agreement
  - (c) provide 2 (two) Club Committee Members of which 1 (one) member must be an executive member of the Club's Management Committee to represent the Club and/or provide 2 (two) Club representatives empowered to make decisions on behalf of your organisation if they are compliant with Rule 9
  - (d) attend meetings, actively and constructively participate in the discussions and decision making process and know that non-attendance or disruptive or disrespectful behaviour may result in individual and/or Company disciplinary action or expulsion
  - (e) follow the rules of the Company, management, administration, processes, policies and procedures, rules of the sport, Code of Conduct and Codes of Behaviour of the Company, and its representatives, land owners and/or land managers
  - (f) be responsible for the actions of your organisation's members and those visitors attending or participating in the Company's activities and or events
  - (g) ensure the needs of the Club's most valued resource, its volunteer workforce, are supported by modern volunteer policies, procedures, codes and practices
  - (h) recognise and reward the commitment and contribution of the Club's volunteers according to the Company's volunteer policies, procedures and industry standards
  - (i) when representing the Company, do so in a manner that reflects and promotes the objectives of the Company and pistol shooting
  - (j) know the Company is empowered to set the standard and penalties for non-compliancy.'
- 4. Conduct the approved Pistol Australia and Australian International Shooting Ltd (AISL) matches for Pistol Australia members only in accordance with the constitutions, rules and requirements of Pistol Shooting Queensland and Pistol Australia.
