1. For all existing accredited course holders. Staff: PSQ Board Members, Athletes, Coaches, Officials, PSQ Coordinators & volunteers are required to complete the required courses in the timeframe specified or their accreditation will be suspended until such time that they complete the course/s.
2. Any members who require reaccreditation in their area will be required to complete the required courses prior to the reaccreditation process commencing.
3. For all new applicants applying for qualifications with accreditation or where the position is relevant to completing a course, members will be required to complete these courses and obtain a Working With Children Card (WWCC) prior to commencing the course.
4. All Coaches, Officials, PSQ Board Members, PSQ Coordinators are to have a current WWCC.
5. Once you have completed the required courses you can obtain a Certificate from the Sport Integrity Website which will be required to be forwarded to Pistol Shooting Qld on the email of [sportintegrity@pistolshootingqld.org.au](mailto:sportintegrity@pistolshootingqld.org.au)
6. If you are a National level athlete, coach or official please see the Education Plan Attachment A (I) as there may be different requirements than at state level.
